This position is appointed by the Chief Judge of the Saginaw County Trial Courts and the Judges of the 70th District Court. The Attorney Magistrate serves in a quasi-judicial capacity as prescribed by statute under the direction of the Presiding Judge of the 70th District Court.

#### Typical duties include:

- · Hearing and presiding over traffic civil infractions, following a hearing or admission of responsibility.
- Conducting hearings in civil actions, including rendering judgement and making decisions.
- Hearing and presiding over pre-trials for traffic civil infraction and misdemeanor actions.
- Signing arrest and search warrants as properly authorized.

Pursuant to MCLA 600.8501 the Magistrate shall be appointed by the Judges of the District and the appointment shall be subject to approval by the County Board of Commissioners.

Experience: Minimal experience (less than one year) in the general practice of law including criminal/traffic law or equivalent combination of education and experience.
