



## CIRCUIT COURT CHIEF JUDGE'S CORNER

#### DIGITAL VIDEO COURT RECORDING SYSTEM INTRODUCED IN SAGINAW COUNTY CIRCUIT COURT

On July 22, 2024, Courtroom 407 (Judge Julie A. Gafkay) implemented digital video court recording with plans for the other four circuit courtrooms to add video within the next year. The courtroom was fitted with high-quality digital video recording equipment. For the last couple years, the circuit court has been equipped with digital audio recording equipment. The video equipment added 5 voice-activated cameras strategically placed throughout the courtroom to record the judge, attorneys, witness, and overview of the courtroom, while keeping the jury out of the view of the camera.

Equipment was also added to both counsel tables allowing counsel to use an HDMI cable to seamlessly display exhibits or a presentation on the courtroom's television screen. A screen has been added to the witness box to allow a witness to view exhibits. The added video court recording system will augment the certified stenographic reporter (CSR), who will continue to transcribe most proceedings. At times, when the CSR is not available, other court personnel will be able to operate the system, which does not require the operator to be certified under MCR 8.108(G)(1), although the CSR will still be needed to prepare any transcripts requested. The addition of video should make the courts more efficient, accurate, and eventually more cost-effective.

Ten practical tips for attorneys appearing in digital video court recording courtrooms

- 1. Speak loudly and clearly.
- 2. Identify yourself properly when making an appearance at the beginning of each proceeding and spell your name for the record.
- 3. Use the MUTE button at counsel table if you wish to consult with your client during a hearing.
- 4. Coughing or sneezing near a microphone will adversely affect the recording.
  - 5. Speak into the microphone.
- 6. Only one person should speak at a time!
- 7. Avoid overlapping questions and answers or colloguv.
- 8. On-the-record bench conferences are conducted at the bench conference microphone.
- 9. Address jurors by number (or name, depending on judge's preference) for proper identification during voir dire.
- 10. Remember the court proceedings are being electronically recorded when the lights are RED.

















#### **UPDATE TO LAO 2024-25 AWOIP**

The 10th Circuit -Juvenile and Family Division has updated the Local Administrative Order referencing the process the Court must take when a youth under its jurisdiction is Absent Without Legal Permission (AWOLP).

AWOLP for abused or neglected youth refers to situations where a minor leaves their "Court Authorized" residence without legal authorization. This term is particularly relevant in cases involving child protective services (CPS) or foster care systems.

When a youth is classified as AWOLP, it indicates their departure from a Court approved placement or home environment. The response to AWOLP cases typically involves immediate efforts to locate the youth and ensure their wellbeing. The Court, social workers, law

enforcement, and community resources collaborate to find the youth, assess their current circumstances, and address any immediate risks or needs they may have.

The overarching goal of responding to AWOLP incidents is to ensure the safety and protection of the youth. This includes assessing the reasons for leaving. addressing underlying issues such as abuse or neglect, and providing appropriate support and interventions to prevent further harm. AWOLP cases require sensitive handling to balance the legal aspects of abuse/neglect cases with the best interests and safety of the youth involved.

The following is the signed Local Administrative Order 2024-05 AWOLP.

Local Administrative Order 10th Circuit Court 2024-05

Rescinds Local Administrative Order Numbers 10th Circuit Court 2003 - 01

#### Reviewing Cases of Children Absent Without Legal Permission (AWOLP)

This local administrative order is issued in accordance with the Michigan Supreme Court Administrative Order 2002-04, and in order to establish a plan for review of cases involving children who are absent from court-ordered placements without legal permission, and to protect those wards of the 10<sup>th</sup> Circuit Court-Juvenile & Family Division.

#### IT IS ORDERED:

#### 1. Establishment of Special Docket or Expedited Review Process

 a) An expedited review process has been established by the Court to ensure that an AWOLP youth's case is reviewed with urgency. This process is outlined under section 4 of this I AO.

## 2. Responsibility for Ensuring Compliance

- a) The Presiding Judge of the Juvenile & Family Division is responsible for supervision of this plan and the on-going efforts to locate children absent without legal permission (AWOLP).
- b) Cases of children absent without legal permission will receive priority oversight from the Juvenile & Family Division. The Court, along with the Michigan Department of Health and Human Services, have committed to monitoring and updating the status of any wards deemed to be AWOLP.
- c) The Presiding Judge's judicial assistant of the Juvenile & Family Division will maintain a list of any children under court jurisdiction AWOLP from approved placements in Saginaw County. The judicial assistant will keep the judge advised of information concerning those children; whether that information is received from the Michigan Department of Health and Human Services, law enforcement, the State Court Administrative Office, or any other source.

#### 3. Coordination of Efforts with Department of Health and Human Services

- a) The Saginaw County Department of Health and Human Services will notify the Judge's judicial assistant of any child who is absent without legal permission. This notification will be by way of filing with the Court the "Unauthorized Leave Report to Court/Law Enforcement" (MDHHS 3198A) within 24 hours/1 business day after the child is identified as AWOLP. This will involve electronic, as well as hard copy notice provided by supervisors designated by MDHHS to perform this function.
- b) The Court will issue an "Order to Take/Place into Temporary Custody" the same day the Court is notified of the AWOLP.
- c) The designated MDHHS liaison responsible for MDHHS efforts to locate AWOLP children is Teri June, Program Manager.

## 4. Process for Review of Cases involving AWOLP children.

- a) The Court will schedule an initial review hearing or a case status conference to ascertain steps that may be taken to locate, secure and appropriately place the child within 24 hours of the Court being notified of the AWOLP. At this hearing or case status conference, the Court will ensure the following:
  - Determine persons of interest who may have information to aid in locating the missing child.
  - Make decisions regarding actions to be taken to locate the missing child.

- Determine the appropriate actions to be taken when the missing child has been located.
- iv. The initial review process will include review of MDHHS reports, reports from law enforcement, and information received or maintained by the court.
- b) A status conference with MDHHS shall be scheduled within seven days of notification that a child is AWOLP. This status conference will allow the Presiding Judge to assess "active efforts" the MDHHS has been involved with to locate the child.
- c) After the expedited hearing, hearings will be scheduled, as needed, ensuring at least seven days' notice to interested persons. A hearing must be scheduled every 30 days to re-evaluate the progress of the department in locating the child.
- d) Should the Presiding Judge of the Juvenile & Family Division be unavailable, for any reason, the Senior Juvenile & Family Division Referee will provide oversight and direct action consistent with this administrative order.

#### 5. Identified Special Problems

a) No special issues have been identified that may delay implementation of this order. Presidina Judae will confer regularly with the Director of the Michigan Department of Health and Human Services. This ongoing communication will identify and remedy systemic problems, as they arise. Any special case specific issues that may arise will be dealt with through the status conference and/or hearing process for that case.

## 6. Obtaining Information and Scheduling Hearings

- a) Information required by the court on AWOLP cases will be provided to the court by the designated MDHHS worker within 24 hours of a scheduled hearing and includes:
  - i. All pertinent available information in the MDHHS case file related to the potential location of child. This includes family members, unrelated caregivers, friends, known associates, churches, or a neighborhood center.
  - ii. All information related to the school that the child last attended to verify that the child is not in attendance and determine if there are friends/ teachers who may have information.
  - All information related to the MDHHS diligent search checklist.
- b) Procedures that will be used to obtain information that will assist in efforts to locate AWOLP children include:
  - i. In its discretion, the Court may use informal measures to locate. communicate with and ensure proper placement of an AWOLP child. In all cases, the Court will utilize all statutory and court rule authority to locate and expedite return of the AWOLP child to proper placement. The Court will also offer assistance. consistent with this to Saginaw County and the Michigan Department of Health and Human Services in locating all AWOLP children, even if the child involved is not a current ward of the 10th Circuit Court-Juvenile & Family Division. The only exception to this is the Court will not duplicate efforts of another court within this state.

- ii. The MDHHS, in cooperation with this plan, will provide the court all information requested using the procedures listed below:
  - DHS-3198A Unauthorized Leave Report to Court/Law Enforcement.
  - DHS-710 Clearance to Publish Children AWOLP on MDHHS Web and NCMEC Web.
  - 3. DHS-991 Diligent Search Checklist.
- AWOLP review hearings will be scheduled every 30 days a child remains in AWOLP status.

## 7. Priority to Cases of Children Ages 15 and Younger

 a) Because of the high priority of cases involving children under 16 years of age, the Presiding Judge will personally monitor and report on the status of these children absent without legal permission. Reports will be updated, as circumstances indicate, and that information will be provided to the Chief Circuit Court Judge and the State Court Administrative Office. b) The presiding Judge will also consult with the 10th Circuit – Juvenile and Family Division Court Administrator to ensure that all updates to the state MCAP system occur the 1st of every month. This is to ensure that accurate and up to date information is provided on these children.

#### **Effective Date**

This plan shall take effect upon approval of the State Court Administrative Office.

#### **BANKRUPTCY CASE NOTES**

Does the Bankruptcy Court look to the original source of a debtor's claimed exemption? That was the issue before Bankruptcy Judge Daniel S. Opperman, in the case of Kevin Michael Majeski, 22-20947 decided on May 11, 2023. Debtor claimed an exemption for his 2021 tax refund; however, his Trustee objected to his claimed exemption. The Court heard the parties' respective arguments and issued its decision on May 11, 2023. The Court noted that the parties generally agreed to the facts but had different legal conclusions.

Debtor had filed for Chapter 7 bankruptcy relief on September 27, 2022. In his schedules, he noted a 2021 tax refund that had not yet been received and was joint with his ex-wife. Subsequently, debtor amended his Schedule C and claimed an exemption for the IRA penalty refund check he had received in the amount of \$3,113.00, which he exempted per MCL \$600.5451(1)(k). The Trustee objected, claiming that those monies were merely a tax refund and therefore, not exempt.

Debtor's position was that the source of the tax refund was due to his early retirement withdrawal due to his permanent disability and because the law would not allow him to re-deposit those monies into his IRA account, that he should be allowed to exempt those monies. Factually, debtor was under the age of 59 ½, and could not withdraw his IRA monies without paying a 10% penalty, which had been automatically deducted and paid by his IRA administrator to the US Treasury Department. Thereafter, debtor filed his 2021 tax return and received those penalty monies back in a refund

check after he had filed for bankruptcy.

The Court, in its decision, cited MCL § 600.5451(1)(k) and was guided by the general principle that exemptions are to be liberally construed in debtor's favor pursuant to the bankruptcy code's general policy of granting debtors a fresh start. Further, that Bankruptcy Rule 4003(c) placed the burden of proof on the Trustee to prove that debtor's exemption was not properly claimed.

Judge Opperman concluded that MCL§ 600.5451(1)(k) allowed a debtor to exempt all individual retirement accounts and the distribution from those accounts. Those types of assets retain their exempt status. The Court upheld Mr. Majeski's logic in tracing those exempt funds from his IRA monies withheld by his IRA administrator, paid to the United States Treasury, and returned to Mr. Majeski in the form of an income tax refund. The Court concluded that the \$3,113.00 was exempt and denied the Trustee's objection.
